

NON-COMMERCIAL COMMUNITY LICENSE AGREEMENT RE CORTEX

By using any aspect of the Cortex System (e.g., by creating Products on the Cortex Platform), you acknowledge that you have read, understand and agree to be bound by this Non-Commercial Community License Agreement re Cortex ("License"). This License governs your use of the Cortex System for non-commercial purposes. If you do not agree to this License, then you must not use the Cortex System.

The Cortex System is operated by Fandom, Inc, a Delaware corporation, with offices at 130 Sutter Street, 4th Floor, San Francisco, CA 94104 ("Fandom"). **"Cortex System"** means Fandom's tabletop roleplaying gaming systems Cortex Classic, Cortex Plus and Cortex Prime.

You acknowledge and agree that Fandom owns all trademarks and copyrights in and to the Cortex System. You agree not to contest Fandom's ownership of any intellectual property rights in or to the Cortex System, during the term of this License or thereafter. You also agree not to create or use any names or trademarks similar enough to our trademarks that consumers could be confused about whether your material was produced by or on behalf of Fandom.

1. LICENSE.

Subject to your compliance with all of the terms and conditions of this License, Fandom grants you a personal, limited, non-exclusive license to use the Cortex System to create Cortex System-compatible products ("Products") for your personal, limited non-commercial use. The Cortex System may only be used in the manner specified in the License and any commercial use of the Products is prohibited, unless expressly agreed otherwise by Fandom. You are prohibited from sub-licensing, renting, leasing or otherwise distributing the Cortex System or rights to use the Cortex System.

2. USAGE RESTRICTIONS.

Your right to create Products using the Cortex System is limited to the license grant above, and you may not otherwise copy, display, seek to disable, distribute, perform, publish, modify, create works from, or use the Cortex System or any component of it. You may not remove or alter Fandom's trademarks or logos, or legal notices included in the Cortex System or related assets.

You may not use the Cortex System in a way that suggests Fandom owns, endorses, or is in any way responsible for any part of your Product, or for any conduct of your business, or that suggests that you have any relationship beyond a mere license with

us, unless we have a separate agreement that lets you do so. You also may not state or suggest that we guarantee your Product's compatibility with the Cortex System.

The titles of your Products may not include any Fandom trademarked terms (or marks confusingly similar thereto).

You may not use Fandom's trade dress for your Products or advertisements—that is, you may not design your Products or advertisements to look confusingly similar to Fandom's products or advertisements.

You may not do anything illegal in or with your Products.

You must use your best efforts to preserve the high standard of our trademarks. You may not use this License for material that the general public would classify as "adult content," offensive, or inappropriate for minors.

3. COMPATIBILITY.

In order to make use of the Cortex System, your Products must operate under and rely on the Cortex System. You agree to use your best efforts to ensure that Products are fully compatible with the Cortex System. Products may additionally be compatible with other systems.

4. REPRESENTATIONS AND WARRANTIES.

You represent and warrant that your use of the Cortex System and related Products (i) does not violate any law, rule or regulation; (ii) does not violate any intellectual property rights of any third-party, (iii) is not inappropriate, profane, indecent, harmful, threatening, abusive, defamatory, harassing, tortuous, vulgar, obscene, libelous, pornographic, harmful to minors, racially, ethnically or otherwise objectionable or that may be invasive of another's right of privacy or publicity; (iv) does not contain any macro, bot, virus, trojan horse, keystroke logger, worm, time bomb, cancelbot, corrupted data or other file, code or computer programming routing that is intended to or results in damage, detrimentally interferes with the Cortex System.

5. RESERVATION OF RIGHTS.

Except as expressly licensed to you herein, Fandom reserves all right, title and interest in the Cortex System, and all associated copyrights, trademarks, and other intellectual property rights therein. This License is limited to the intellectual property rights of Fandom and its licensors in the Cortex System and does not include any rights to other patents or intellectual property. Except to the extent permitted under applicable law,

you may not decompile, disassemble, or reverse engineer the Cortex System, or any component thereof, by any means whatsoever. You may not remove, alter, or obscure any product identification, copyright, or other intellectual property notices in the Cortex System. All rights not expressly granted herein are reserved by Fandom.

6. TERM AND TERMINATION.

The term of your License shall commence on the date that your application is accepted by Fandom.

Your rights under this License will terminate immediately and automatically without any notice from Fandom if you fail to comply with any of the terms and conditions of this License.

In addition, we can terminate this License at any time, at our sole discretion, upon notice to you.

If we terminate the License for any reason other than breach, you may no longer make any new Products hereunder that utilize the Cortex System

To the fullest extent permitted by applicable law, the laws of the State of California, without regard to principles of conflict of laws, govern this License and any dispute of any sort that might arise between you and Fandom or any of its affiliates.

12. UPDATES.

Fandom may update, amend, alter, or modify this License in the future. You agree that Fandom may make changes to this License at any time and for any reason at its sole discretion. We will try to give you reasonable notice of any major changes.

13. SEVERABILITY AND SURVIVAL.

If any provision of this License is illegal or unenforceable under applicable law, the remainder of the provision shall be amended to achieve as closely as possible the effect of the original term and all other provisions of this License shall continue in full force and effect.

14. ENTIRE AGREEMENT.

This License constitutes the entire agreement between you and Fandom with respect to the Cortex System and supersedes all prior or contemporaneous understandings regarding such subject matter. No amendment to or modification of this License will be binding unless made in writing and signed by Fandom. No failure to exercise, and no delay in exercising, on the part of either party, any right or any power hereunder shall operate as a waiver thereof, nor shall any single or partial exercise of any right or power hereunder preclude further exercise of any other right hereunder. In the event of a conflict between this License and any applicable purchase or other terms, the terms of this License shall govern.
